As retribution, Marshal Antonescu orders

1) Execute all Jews from Bessarabia, now refugees in Odessa.

2) All persons subject to provisions of order no. 3161 (302 858) of October 23, 1941, still alive, as well as others that can be added to them will be locked in a building where explosives will be previously placed, which will be blown up. Do this on the day of burying the Romanian victims.

3) Destroy this order after reading it.

Capitan, the telegram is strictly secret. After decrypting, deliver it only to General Iacobici or, in his absence, to General Tataranu. No intermediaries.

General Iacobici and General Tataranu have left half an hour ago to for Tighina. I will resend this telegram to Gloria Tighina for delivering it to General Iacobici. After sending it I will destroy the encrypted text (all tapes) without decrypting them, following that the decrypting be made only [*letters not making sense in Romanian*] after [*letters not making sense in Romanian*].

Excuse me. Who is the highest ranking there? And how long will the Generals stay in Tighina?

The highest ranking here is Colonel Stanculescu, Deputy Chief of Staff. General Iacobici and General Taranu left to Bucharest and will spend the night in Tighina.

I will respond at once.

Capitan, please submit the telegram to whoever replaces General Tataranu. That person will decide what to do.

[*letters not making sense in Romanian*] Alright. Understood.
